Message from the new CEO

he World Health Organization has designated 2020 as the "International Year of the Nurse and the Midwife" in honor of the 200th anniversary of Florence Nightingale's birth. It is also NPWH's 40th anniversary in 2020! Happy Year of the Nurse and the Midwife! Happy Birthday, NPWH! We see you and we celebrate you!

Although every transition to a new job is eventful, I didn't anticipate my tenure as CEO to begin in the middle of a global pandemic. I recognize that this crisis of COVID-19 is affecting our members in different and complicated ways. We at NPWH are thinking of you and hoping that you and your families are safe, healthy, and finding ways to take care of yourself and others during this unusual time.

Whether you are on the front lines, working hard to continue providing care, or furloughed, I want you to know that we stand with you. We value your membership and are working hard to support you and help you continue to instill trust in the women you serve with your expertise and compassion. We recognize a strong WHNP workforce is key to the achievement of improving women's health, promoting gender equality, and supporting economic equity in the United States. WHNPs must be properly valued and represented in health leadership roles where you can guide health policy and investment.

NPWH is part of the urgent conversations about healthcare that the COVID-19 crisis is creating, and we want to stay on top of understanding your needs beyond COVID-19. We encourage you to fill out this short survey^A that will help us better understand your experience and create resources helpful to you in this unprecedented era. We will continue to advocate for our members by speaking to the administration and congressional members about the specific needs of WHNPs and women in this crisis.

Recently, we supported amicus briefs to protect a woman's right to abortion care in Texas and Oklahoma. We also signed a letter organized by the March of Dimes to the House and Senate leadership requesting \$100 million in the next COVID-19 relief

bill for the CDC initiative "Surveillance for Emerging Threats to Moms and Babies." This nationwide network was created during the Zika virus outbreak to track the virus' effect on mother and infants in real time, enabling the CDC to create evidence-based clinical guidance, educate healthcare providers and the community, and connect families to care. The letter urges Congress to provide new funding to renew and improve this initiative to gather real-time clinical and survey data from all 50 states and jurisdictions on the impact of COVID-19 on pregnant women and their babies.
